TERMS AND CONDITIONS

- You and your immediate Muslim family members, including yourself, your spouse, and all unmarried children, are eligible to enroll for funeral services provided by the Islamic Foundation of Canada as a family unit.
- Upon commencement of marriage of children, individuals will no longer be automatically covered under the family membership. At this point, they must enroll separately as a family unit.
- In cases where parents reside with you in Canada, they must be enrolled separately



as members to ensure coverage under the funeral services.

- It's important to note that the coverage for funeral services is valid exclusively within Canada and does not extend beyond its borders.
- As part of our commitment to supporting the community, if you are aware of any Muslim families experiencing financial hardship, you have the opportunity to sponsor their membership to ensure their access to these essential services.

Membership Duration:

Your membership is valid for a lifetime from the date of enrollment, as long as your contributions per death do not default.

Contribution Requirement:

The member is required to contribute to the funeral cost of any member of the funeral plan, which will be directly deducted from their direct deposit account. This contribution is a condition of their membership.

Coverage Limitations:

The coverage provided under this service is specifically for funeral services within Canada. It does not extend to cover additional expenses such as the transportation of the deceased outside of Canada, repatriation costs, or any other related expenses.

Change of Address/Payment Method & Updating Information:

It is your responsibility to promptly inform the Islamic Foundation of Canada (IFC) of any changes in your address, contact information, payment method, membership information: adding/removing members will incur a fee of \$20 per update.

Notification of Death:

In the unfortunate event of a covered individual's passing, the immediate family or legal representative must notify IFC promptly.

Payment of Dues:

Failure to pay dues may result in a lapse of coverage, and re-enrollment may require fulfilling additional conditions.

Transferability:

Please be aware that membership in the funeral services provided by IFC is non-transferable. It cannot be sold, assigned, or transferred to another individual or entity.

Termination of Membership:

IFC retains the right to terminate membership in cases involving fraud, misrepresentation, or violation of any terms and conditions outlined in this agreement. Such termination will be conducted in accordance with our internal policies and procedures.



Communications:

By enrolling in our services, you consent to receive communications from IFC, including updates, notifications, and promotional materials related to our funeral services and community initiatives.
